This is good news considering the enormous impact of the Lorry Park proposal on the Council's time and resources. I would like to thank all of the Councillors personally for the work they have done during this last year to ensure we have stayed on top of things during our fight against the Lorry Park. I would like to extend these thanks to residents who, as members of SOS Kent, have provided an invaluable contribution to the cause. ## OPERATION STACK



Given its effect on all our lives over the last 12 months it is probably inevitable that I should start this Newsletter with an update on the Lorry Park. As I write, a Judicial Review (JR) has been launched against the Lorry Park by the owners of Westenhanger Castle, G Forge. The Parish Council is listed as an interested party in that JR. Highways England will cease further work on the site until this is resolved. The Parish Council has opted to be an interested party, based on advice from our legal team that it will mitigate costs while retaining the potential to launch our own JR at a later date if necessary. Consequently we are still

fund-raising to pay for the legal fight. The grounds for the JR are as follows:

1. The project should have been classified as EIA development. This places a duty on the Secretary of State to consider the environmental effects before making his decision. Highways England has failed to undertake a full and proper assessment of the likely significant environmental effects of the Project, which would normally take the form of an EIA (Environmental Impact Assessment Report). Instead HE has produced an Environmental Impact **Analysis**, which is incomplete, has errors and is non-statutory. Also HE has not finalised the Project and, therefore, a decision to proceed would be premature as the environmental effects cannot be quantified. If the JR succeeded in having the project classified as EIA development, HE would have to complete a full EIA and correct all the errors in their current documents.

2. The project should be classed as an alteration/improvement to an existing special highway, which makes it a nationally significant infrastructure, subject to a Development Consent Order (DCO) with attendant red tape. If the project is deemed to be subject to a DCO by a JR, then it would be likely to impose a minimum of 12 months of delay on the project.

**While these challenges do not provide a “silver bullet” to stop the lorry park, if successful they may achieve a delay of up to 2 years (including the JR process). In that time the political/economic landscape may change and support/funding for the lorry park could disappear, particularly if we see limited use of Operation Stack.**

To pursue a JR the Parish Council needs to raise in the region of **£35,000**, made up of:

- £5,000 – Cost of preparing and submitting a JR
- £20,000 – Court process etc if JR granted
- £10,000 - Potential costs to HE if we lost our JR

## PARISH MAINTENANCE

To date we have raised approximately £15,000 and we are very grateful indeed for all the donations we have received from our residents and also from supporters from other areas.
